

# VA IRRRL

## Program Guidelines



<b>What is Virginia Housing's VA IRRRL program?</b>	Virginia Housing's VA Interest Rate Reduction Refinance (IRRRL) program is a refinance program offered only to borrowers with current Virginia Housing VA or VA Bond loans. The loan is securitized by Ginne Mae via a mortgage-backed security (MBS). Requirements of this streamline refinance program are listed below.								
<b>Loan Term</b>	30 year fixed rate only.								
<b>Maximum Lender Compensation</b>	2.50% including SRP plus common and customary ancillary fees.								
<b>Loan-to-Value (LTV)</b>	Follow VA requirements.								
<b>Eligible Mortgages</b>	<ul style="list-style-type: none"> <li>• Virginia Housing VA</li> <li>• Virginia Housing VA Bond</li> </ul>								
<b>Mortgage Insurance</b>	Funding Fee per VA requirements.								
<b>MCC Eligible</b>	No. An existing MCC will not be re-issued if the loan is refinanced.								
<b>SPARC Eligible</b>	No.								
<b>Plus Second Mortgage Eligible</b>	No.								
<b>DPA Grant Eligible</b>	No.								
<b>CCA Grant Eligible</b>	No.								
<b>First-time Homebuyer</b>	Not required.

<b>Maximum Loan Amount</b>	Follow VA requirements / Energy efficient improvements may not be included.								
<b>Eligible Purpose</b>	Primary residence / owner occupied interest rate reduction refinance.								
<b>Financed Closing Costs</b>	Allowed per VA requirements.								
<b>Programs Disclosure and Borrower Affidavit (Exhibit E)</b>	Not required.								
<b>Seller Affidavit (Exhibit F)</b>	Not required.								
<b>Originating Lender's Submission Cover Letter (Exhibit O)</b>	Not required.								



<b>Recapture</b>	Loan is not subject to recapture.
<b>Homebuyer Education</b>	Not required.
<b>Automated Underwriting System (AUS) / Manual Underwrites</b>	Desktop Underwriter and Loan Product Advisor Total Scorecard not allowed. Loan must be manually underwritten meeting the more restrictive of Virginia Housing and VA IRRRL requirements.
<b>Minimum Credit Score / Verification of Mortgage</b>	No credit score requirement – this is a no credit qualifying refinance. Lenders must obtain a credit report to identify: <ul style="list-style-type: none"> <li>• Judgments or liens.</li> <li>• Credit scores to be provided if available.</li> </ul> Verification of the mortgage directly from Virginia Housing is required to confirm: <ul style="list-style-type: none"> <li>• An acceptable mortgage payment history (no lates last six months paid by borrower obtaining VA Interest Rate Reduction Refinance).</li> <li>• The note date of the refinance loan must be on or after the later of: <ul style="list-style-type: none"> <li>• The date that is 210 days after the first payment due date of the loan being refinanced, and</li> <li>• The date on which 6 full monthly payments have been made on the mortgage being refinanced.</li> </ul> </li> </ul> Mortgages with prior modification or partial claims are not eligible.
<b>Maximum DTI</b>	No maximum ratios with VA IRRRL.
<b>Addition and Removal of Borrower</b>	Follow VA requirements.
<b>Non-Occupant Co-Borrowers</b>	Not allowed.
<b>Acceptable Funds to Close</b>	Follow VA requirements for funds to close (Must verify borrower's funds to close).
<b>Cash Back at Closing</b>	Follow VA requirements for cash back at closing (Loan must involve no cash back to borrower except for minor adjustments at closing not to exceed \$500).
<b>Appraisal</b>	Not required.
<b>Flood Certification</b>	A new flood certification is required.

<b>General Guidelines</b>	Unless otherwise noted follow VA IRRRL requirements (with program overlays).
<b>Lock-In</b>	Loans locked on Virginia Housing's LOS – <a href="#">Mortgage Cadence</a> – Select <b>VA30F_IRRRL</b> . Follow steps outlined in the <a href="#">Mortgage Cadence User Guide</a> for registering and locking loans.
<b>LLPAs</b>	No additional Loan Level Pricing Adjustments (LLPAs).
<b>Origination</b>	Loan originated in accordance with program guidelines and VA guidelines.
<b>Lender Delegated Underwriting Availability</b>	All approved Virginia Housing lenders are automatically delegated for the VA IRRRL program (Even lenders that are not delegated on other products).
<b>Underwriting</b>	Loans underwritten in accordance with program guidelines and VA guidelines. PITI increases $\geq 20\%$ are not eligible in conjunction with Virginia Housing financing. Loan must meet VA's 36 months' recoupment requirement.  Follow steps outlined in the <a href="#">Mortgage Cadence User Guide</a> for submitting for Delegated Approval.
<b>New Escrow Account</b>	A new escrow account must be established: <ul style="list-style-type: none"> <li>• A refund of the current escrow account will be sent to the borrower after the refinance has been completed and payoff of the original loan is received.</li> <li>• When establishing the new escrow account, include the amounts necessary to pay the hazard premium and taxes in the month prior to the due date. A two month cushion is required.</li> <li>• The borrower is not required to obtain a new hazard policy.</li> </ul>
<b>Loan Payoff Information</b>	For loan payoff information: <ul style="list-style-type: none"> <li>• Fax request to 804-343-8720; indicate that this is a Virginia Housing to Virginia Housing refinance and attach the Borrower's Authorization.</li> <li>• For a faster turn time use AutoFax Payoff by calling 800-235-6938; press 1, press 2, then press 4 for a faxed payoff statement.</li> </ul>
<b>Closing</b>	Loans closed in accordance with standard VA guidelines.  Loan must be closed in the name of the lender, registered in MERS with MERS compliant documents.
<b>Funding</b>	Originating lender will fund the first mortgage at closing.
<b>Delivery</b>	Loans submitted to Virginia Housing within 10 calendar days of closing. Follow steps outlined in the <a href="#">Mortgage Cadence User Guide</a> for submitting a closed loan package.  Documents must be uploaded using the <a href="#">Loan Stacking Form</a> .
<b>Pre-Purchase Review</b>	Loans reviewed by Virginia Housing prior to purchase. If errors noted, Virginia Housing will contact lender.
<b>Post-Closing</b>	Standard post-closing documents must be submitted to Virginia Housing.
